Release of Liability, Waiver & Indemnity Agreement

1. Use of Property at Your Own Risk

By staying at NamibgreNS Guest Farm, you and all members of your party (including children) do so entirely at your own risk.

NamibgreNS Guest Farm, its owners, and staff accept no responsibility for any:

- Injury, illness, or death
- Loss or damage to property (including theft)
- Financial or emotional loss

whether caused directly or indirectly, and regardless of the cause (including negligence or recklessness).

2. Wildlife, Environmental & Health Risks

Guests acknowledge and accept the presence of wild animals, reptiles, insects, and other natural hazards on NamibgreNS Guest Farm. This includes baboons, snakes, scorpions, spiders, bugs, and other unpredictable wildlife.

- Do not feed, approach, or disturb wildlife.
- Maintain a safe distance from all animals.
- Protect the environment — do not remove or damage plants, rocks, or natural features.
- Keep doors and windows closed when leaving facilities — baboons and other animals may enter unattended buildings.
- Use eco-friendly toiletries and dispose of waste responsibly.
- Serious sunburn and heat exhaustion may result from sun and heat exposure — wear proper protection and stay hydrated.
- Guests are responsible for their own health and safety at all times.

3. Indemnity & Waiver of Claims

By signing this form, you:

- Waive any current or future claims against NamibgreNS Guest Farm, its owners, or staff.
- Indemnify and hold harmless the farm, owners, and staff (“the Indemnified Parties”) from any claim brought by:
 - Yourself or anyone in your group,
 - Your dependants, guests, or invitees,
 - Any party accessing the premises through you.
- Accept full responsibility for your own actions, as well as the actions of those in your party.

This waiver includes all claims related to:

- Personal injury, illness, or death
- Damage to or loss of property
- Any act or omission by yourself or others, whether negligent or otherwise

In the event of serious injury or illness, NamibgreNS Guest Farm may, at its discretion and without admission of liability, arrange emergency medical assistance.

4. Binding Agreement

This agreement:

- Applies to you, your spouse, heirs, next of kin, executors, and assigns;
- Is governed by the laws of Namibia;
- Applies equally to all guests listed in your party;
- Uses the singular to include the plural (e.g. “Guest” includes all listed guests).

5. Acknowledgement & Signature
